I have reviewed and considered the City of Bainbridge Island's Conflict of Interest policy in the City's Ethics Program, I am committed to complying with that policy, and I am hereby completing this Conflict of Interest Statement, as required by Article II, Section H, of that policy.

In accordance with the Conflict of Interest provisions set forth in Article II of the City's Ethics Program, I hereby attest, to the best of my knowledge and belief, except as disclosed herein and allowed by state law and the exceptions and waivers in the Conflict of Interest provisions of the City's Ethics Program, the following:

- (1) Except as provided by the below described exception, I shall not directly, or indirectly through a subordinate or fellow officer, official, or employee, take any direct official action on a matter on behalf of the City if I, or a member of my immediate family:
  - a. Has any substantial direct or indirect contractual employment related to the matter;
  - b. Has some other financial or private interest in that matter, including by serving on a Board of Directors for any organization related to that matter; or
  - c. Is a party to a contract or the owner of an interest in real or personal property that would be significantly affected by the action.
- (2) Exception: The requirement in Section (1) above shall not apply if, as a member of a City Committee, Commission, or Board, I fully disclose the financial interest at issue on the public record of the City Committee, Commission, or Board, and the Committee, Commission, or Board votes to allow me to participate in the discussion or vote.
