**\*\*Please arrive on time and with completed application(s) photo(s) and all photocopies (see instructions below) or your appointment may need to be rescheduled\*\*. DO NOT ATTACH PHOTOS TO APPLICATION!**

## PLEASE BRING THE FOLLOWING TO YOUR APPOINTMENT:

- ALL PERSONS APPLYING FOR PASSPORT MUST BE PRESENT, INCLUDING MINOR CHILDREN AND PARENTS OF MINORS.**
- COMPLETED APPLICATION (DS-11 FORM) - *Single Sided and Typed or Black ink. WE CAN NOT PROCESS DS-82 FORMS.***
- 2 X 2 PASSPORT PHOTO** – The Court takes photos \$10/person. Walgreens, Nick Felkey Photo, UPS Store, Walmart, and CVS offer passport photos. ***Photos need to be less than 6 months old. DO NOT TAKE YOUR OWN PHOTOS!***
- PRIMARY EVIDENCE OF U.S. CITIZENSHIP *and single-sided photocopy of front and back of one of the following:***
  - Original or Certified Copy of Birth Certificate (electronic versions are not acceptable).
  - Previously Issued, undamaged U.S. Passport
  - Original Certificate or Consular Report of Birth Abroad
  - Original Certificate of Citizenship
  - Original Naturalization Certificate
- PRIMARY IDENTIFICATION *and single-sided photocopy of front and back of one of the following:***
  - Valid Washington State Driver's License or Washington State I.D. (not temporary)
  - Current U.S. Passport (cannot be used as both primary evidence of citizenship and primary I.D.)
  - Federal Agency I.D.
  - Valid Military or Dependent I.D.
  - Permanent Resident Card
- PASSPORT FEES**
  - A separate check or money order is required for each application.
  - An additional check is required for City's processing fees.
  - Please bring blank checks, the acceptance agent will provide you with amounts.
  - If sending a check with applicant do not fill out the date or amount. Ok to sign check.

## SPECIAL REQUIREMENTS FOR MINORS

### MINORS (UNDER 16) AND PARENTS OR LEGAL GUARDIANS MUST APPEAR AND:

- If only one parent/guardian can appear, you must submit a notarized Statement of Consent for non-appearing parent/guardian (DS-3053) along with a photocopy of front and back of the i.d. used for the notary.
  - Submit evidence for minor's U.S. citizenship ***and single-sided photocopy of front and back.***
  - Submit original or certified copy of evidence of parental relationship listing parents' names (i.e., Birth Certificate, Adoption Decree) ***and single-sided photocopy of front and back.***
  - Both Parents/Guardians valid photo I.D. ***and single-sided photocopy of front and back (for each application if multiple children).***
  - Renewals of Children require both birth certificate AND previously issued passport ***and single-sided photocopy of front and back.***
- MINORS (AGE 16 OR 17) AND ONE PARENT OR LEGAL GUARDIAN MUST APPEAR AND:**
- Submit evidence for minor's U.S. citizenship ***and single-sided photocopy of front and back (for each application).***
  - Parent AND minors who are 16 or 17 must present valid photo I.D. ***and single-sided photocopy of front and back (for each application).*** (Student I.D. is acceptable for minor if they do not have a driver's license).
  - Current U.S. Passport (cannot be used as both primary evidence of citizenship and primary I.D.)
